

## **IMPORTANT**

### **COURT ORDER IN RELATION TO WALLEYS QUARRY AND RED INDUSTRIES' HEAD OFFICE**

On 24 May 2022, the court approved an order whereby Walleys Quarry Limited, Share Properties Limited, Red Industries (Stoke) Limited and Red Industries Limited and 26 named Defendants agreed, by consent, that an interim injunction which had been made against the named Defendants should be made final.

The court also made an order in similar terms for an indefinite period against the following “persons unknown” described below:


**PERSONS UNKNOWN OBSTRUCTING OR INTEFERING WITH ACCESS  
TO AND FROM WALLEY’S QUARRY ON CEMETERY ROAD,  
NEWCASTLE UNDER LYME**

**and**

**PERSONS UNKNOWN ENTERING OR ATTEMPTING TO ENTER ONTO  
THE LAND AND BUILDINGS KNOWN AS BOROUGH HOUSE,  
BOROUGH ROAD, NEWCASTLE UNDER LYME WITHOUT THE  
PERMISSION OF THE SECOND OR FOURTH CLAIMANT**

**The effect of this order is to prohibit ‘persons unknown’ i.e. any other unidentified protestors who have participated in unlawful activities in the past or who intend to do so in the future from:**

1. entering onto or attempting to enter or remain in the “bell-mouth” (see the area shaded green in the image below) entrance to Walley’s Quarry on Cemetery Road, Newcastle under Lyme between the following hours:
  - a. Mondays to Fridays – 6:30am to 7:30pm
  - b. Saturdays – 6:30am – 1:00pm



2. obstructing or interfering with the progress of vehicles entering or exiting the Quarry Entrance or proceeding along Cemetery Road for such purpose at any time.
3. entering onto or attempting to enter the Walleys Quarry Site without the written permission of Walleys Quarry Limited at any time.
4. entering onto or attempting to enter any part of the Head Office site at Borough House (including its car park) (see below outlined in red), Newcastle under Lyme without the written permission of Share Properties Limited or Red Industries Limited.



**PLEASE NOTE anyone who is identified undertaking the actions described may be held to be in contempt of Court and may be imprisoned, fined or have their assets seized.**

**Any other person who does anything which helps or permits a Defendant to undertake the actions described above may also be held to be in contempt of Court and may be imprisoned, fined or have their assets seized.**
